
Deliberation of the Food Safety Commission on the beef and beef offal imported from the U.S.A. and Canada

# . Procedure of the deliberations at the Prions Expert Committee

- Every meeting of the Prions Expert Committee was open to the public.
- Deliberation was conducted based on the scientific data and information collected by the Expert Committee or provided by the risk management agencies. The Expert Committee asked the risk management agencies to provide further information, if necessary.

- . Deliberation of the Prions Expert Committee for risk assessment on the beef and beef offal imported from the U.S.A. and Canada, which was proposed by the risk management agencies on May 24, 2005:

  - Submission by the committee chairman of the draft report which is amended based on the discussions to the committee members for confirmation. Upon confirmation by the committee members, the report was finalized and presented to the Commission.

\* The final draft report of the Expert Committee was presented at the 118th Food Safety Commission meeting on November 2, 2005, and was subjected to announcement for invitation of public comments for a period of November 2 - 29, 2005.

Meanwhile, public hearing meetings were conducted from November 14 through to 22 in seven major cities nationwide.

The collected opinions/information were submitted to all the Expert Committee members for their deliberations. On the basis of deliberations among the Expert Committee members, the draft report was further amended and submitted to the Commission, and the final report was acknowledged and decided to be presented to MHLW and MAFF by the Food Safety Commission.
