
Deliberation of the Food Safety Commission on the revision of BSE measures in Japan

**1** . Procedural chart outlining the assessment of risk arising from the revision of BSE measures in Japan

The Food Safety Commission and the Prions Expert Committee, since their establishments in 2003, have been engaged in the deliberation on the BSE issues in general, while they carried out risk assessments on a few specific BSE issues requested by the risk management agencies.



Request for risk assessment of the proposed revision of domestic BSE measures by the Ministry of Health, Labor and Welfare (MHLW), and the Ministry of Agriculture, Forestry and Fisheries (MAFF) (October 15, 2004)



Deliberation of the Prions Expert Committee (Eight meetings)

A draft report prepared by the Prions Expert Committee (March 2005)



Public Comments being invited on the draft report (From March 31 to April 27 2005)



Food Safety Commission approved the "Food Safety Risk Assessment Related to Measures Against Bovine Spongiform Encephalopathy (BSE) in Japan", and notified MHWL and MAFF accordingly. (May 6, 2005)

## 2. The procedure of the Prions Expert Committee meetings

- All deliberations of the Prions Expert Committee are open to the public.
- The Committee starts discussion on data and evidences collected by them as well as those submitted by risk management agencies. In proceeding with the deliberations, the Committee may request the risk management agencies to submit additional information for further deliberations.
- The chairman prepares a draft report in consultation with the vice-chairman and presents it to each expert committee member for comments. The revised draft report is used as a material for discussion.
- The Food Safety Commission and the Committee were engaged in risk comm unication, in such a way as to be involved in the exchange of opinions with consumers during deliberation process and to invite public comm ents on the final draft report.
